



SAQ Swiss Association for Quality offers personnel certifications of professional qualifications accredited by the Swiss Association for Quality Swiss Accreditation Service (SAS) according to SN EN 17024.

The Certified Commodity Trading Specialist (CCTS) is a SAQ certification in the commodity trading sector and aims to be recognized as a quality benchmark for professionals active in this field.

THE TRAINING
